


In 2014 HEAL worked with a variety of partners to research and build support for policies to improve Utah's air quality. This included: collaborating with legislative allies and coalition members to support a record 22 clean air bills that were introduced in the legislative session (9 of which passed); creating an online bill tracker which was utilized by the media, the public, and state leaders; working with an industrial pollution expert to analyze how industry can make additional emissions cuts; and doing public outreach at tabling events around the Wasatch Front, as well as speaking in front of community groups and classrooms to educate the public about how to improve air quality.

In 2014, HEAL Utah worked to organize and coordinate two trips to Utah from the Under Secretary of State for Arms Control, Rose Gottemoeller in May and October. Because of Utah's history suffering the ill effects of decades of atomic testing at the Nevada Test Site, this is a particularly important place for her to visit to educate members of the public, religious and cultural leaders, and elected officials about the importance of banning nuclear weapons testing through ratification of the Comprehensive Test Ban Treaty.

HEAL's Energy Policy campaign seeks to 1) Promote a gradual transition away from coal-fired electricity 2) Defeat the proposed Green River nuclear reactors and 3) Support policies that encourage renewable energy development. In 2014 this involved: Organizing opposition to the Rocky Mountain Power's proposed fee on rooftop solar owners; planning several large events on clean energy; bringing renowned climate scientist Dr. Michael Mann to Utah to speak on climate change and renewable energy; submitting an appeal to the Utah Court of Appeals in September on the Green River nuclear project's water rights; submitting comments on Utah's Regional Haze plan and organizing the public to do the same; and investigating coal ash contamination in central Utah.

4d OTHER PROGRAM SERVICE

The largest low-level nuclear waste dumpsite in the country is called EnergySolutions, which operates a mile-square nuclear waste disposal facility about 80 miles West of Salt Lake City, Utah. For several years, HEAL has been watching for the state to make a decision on whether to allow the company to bring up to a million tons of depleted uranium—a unique waste—to Utah. While the state did not act in 2014, we continued educating the public, media, and state leaders about the serious concerns we have with this proposal; namely that, unlike the Class A waste that is allowed at EnergySolutions, depleted uranium poses an increasing radiological threat over thousands and millions of years and is not suitable for near-surface disposal.
