HEAL's focus primarily revolved around environmental legislation, with a strong emphasis on three key areas: clean air, clean energy, and toxic waste. Here's a summary of their lobbying activities:

Clean Air:

- **Increased Research Efforts:** HEAL Utah commended legislators for funding

multiple air quality research projects. This included increased funding for gathering data on air quality disparities, ongoing research on wintertime ozone in the Uintah Basin, and expanding monitoring capacity in communities surrounding the Great Salt Lake to collect data on airborne toxins from the newly exposed dry lakebed.

- **Advocating for Emission Prevention:** While supporting research efforts, HEAL Utah also encouraged lawmakers to pass legislation that prevents emissions from industry, buildings, and vehicles from entering the airshed.

Clean Air Legislation that Passed:

- Uintah Basin Ozone Research
- Great Salt Lake Funding for Education and Research
- Regulating Bromine Emissions
- Clean Air Advocacy Efforts:

Zero-Fare Transit Pilot Program: HEAL Utah supported a year-long Zero-Fare Transit Pilot Program and Study, which unfortunately did not receive funding. They helped 126 individuals contact their lawmakers to prioritize this funding.

Opposition to Funding Requests: HEAL Utah opposed a request that funneled taxpayer dollars to Rocky Mountain Power's legal team to fight EPA's emissions reduction requirements. They also opposed legislation creating a new tax on electric vehicle charging stations, helping over 270 individuals reach out to their lawmakers regarding these bills.

Clean Energy:

- **Progress and Regress:** HEAL Utah acknowledged that while some progress was made in clean energy legislation, there were also setbacks. Legislators passed critical bills related to energy and conservation codes for commercial buildings and federal funding for schools' energy and water

conservation efforts. However, they also attempted to pass a joint resolution focusing on the "hazards" of net-zero energy, did not address the social cost of carbon, passed anti-ESG legislation, and failed to pass energy storage incentives.

Toxic Waste:

- Radon Awareness: While there was limited legislation on toxic waste, significant funding was allocated to increase awareness and testing of radon exposure, especially in rural communities. This included providing free radon testing kits and raising awareness of the dangers of radon.
- Classification of Solid Waste: There was a shift in the classification of post-consumer plastics as solid waste, which HEAL Utah will monitor for potential threats.
- Regulatory Agency Funding: The state's regulatory agencies received funding to protect human and environmental health from radioactive exposures, but there were no direct actions taken to strengthen protections for communities from radioactive waste entering the state.

The Organization addresses three main air pollution emission sources—vehicles, area sources, and industry—by working with the state legislature, regulatory agencies, the private business sector, and the general public. HEAL dedicated efforts to enhancing public input, transparency, and accountability within the Utah Inland Port project, engaging with key stakeholders such as the Port Authority staff, board members, and legislators. HEAL was also actively involved in addressing air quality issues, particularly with a focus on ozone standards, providing technical comments on the State Implementation Plan. Moreover, HEAL secured a federal grant from the EPA to implement air quality monitoring equipment on electric buses in Salt Lake County, with the goal of creating a public website for informed air quality decisions and advocating for emission reductions. They played a leading role in a coalition aimed at preserving the Great Salt Lake, focusing on the environmental impact of its exposed lakebed and advocating for the necessary funding and research. Additionally, HEAL's grassroots efforts successfully lobbied for the adoption of updated building codes, gathering input from over 60 community members and recommending sustainable building codes to the state legislature, contributing to improved building efficiency and reduced emissions in Utah.

The Organization addresses nuclear waste issues by harnessing the power of grassroots advocates, educating the public on the technical science behind the hazards of nuclear waste, and watchdogging corporations that profit from it.

In 2022, HEAL's efforts involved opposing the Utah Associated Municipal Power Systems' "Carbon Free Power Project," which includes small modular nuclear reactors (SMNRs), due to concerns about high costs, slow timelines, and a lack of public transparency. They also monitored and opposed Energy Solutions' efforts to bring more toxic waste to Utah, following the permit variance request that could nullify the ban on higher levels of radioactive waste. Additionally, HEAL addressed issues related to uranium milling, advocating for proper monitoring and supporting the White Mesa Community's request for accurate oversight. Furthermore, they actively lobbied for the extension and expansion of the Radioactive Exposure Compensation Act (RECA). A 3 year extension was signed into law in June 2022. HEAL continues to educate and support individuals affected by radiation exposure.

Transition to Clean Energy

The Organization works to combat climate change by focusing on Utah's transition from fossil fuels to renewable energy. The Organization targets changes in industry, legislative and regulatory policy, and individual choices and behaviors.

HEAL partnered with SLC to provide expertise and support in the Community Renewable Energy Program (CREP), aiming to deliver 100% net renewable energy by 2030 in participating municipalities. This involved focusing on renewable energy access for low-income residents and enhancing community

engagement. HEAL also pursued a legal challenge against the EPA's 2017 Regional Haze ruling, which exempted Utah's coal-fired power plants from pollution controls. The lawsuit specifically targeted a Trump-era rule that allowed PacifiCorp to avoid emission reductions, with a hearing set for early 2023. Furthermore, HEAL worked on methane regulation enforcement and opposed fossil fuel extraction expansion in the Uinta Basin, promoting the patching of leaky infrastructure and orphaned wells to reduce methane emissions. They also closely followed developments in the Utah Energy Plan, which adopted an "any of the above" energy approach, and provided input during the comment period.

Sweet Streets

Sweet Streets was founded in 2020 by a team of three that worked to begin brand-building on an advocacy group that would work to watchdog for opportunities to make streets in Salt Lake City safer and more connected for people traveling outside of cars. Transportation is the No. 1 source of particulate matter in the Salt Lake Valley, and the group created a mission and guiding principles to lead the organization into the future. HEAL recognized the Sweet Streets concept - particularly its smart growth, city-building component and positive impact on the climate - as affiliated with its own mission and agreed to act as fiscal sponsor for Sweet Streets. We completed our campaign to lower the speed limit on most Salt Lake City streets to 20 mph. The Salt Lake City Council approved the change in May and posted signs on 73% of streets were changed in the summer. In May we printed dozens of wayfinding signs pointing the traveling public to various locations in neighborhoods across Salt Lake City. The goal of this

initiative was to encourage people to travel outside a car, and to make them aware that often it's not too far to travel outside a car. We hosted a series of walking and biking tours in four neighborhoods throughout town, as well as several Monthly meetups and events to share ideas and grow the network. Lastly we created the 2100 S coalition. It's goal is to turn 2100 South into a true Main Street for the neighborhood, rather than a pass-through surface highway that damages the quality of life on the street.
